- The divisions offered are as follows:
 - 2 Boys/Girls 10s Green
 - 3 Boys/ Girls 12s
 - 2 Boys/ Girls 14s
 - 2 Boys/ Girls 16s/18s
- Players can play "up" one age division, but never a lower age division.

State Eligibility & Age Requirements

- Champ and Super Champ qualified players are **ineligible** to play in the State Championships.
- Players who qualify for Champs on August 1, 2017 or later may still participate.
- Players must play in their local circuits at the age division appropriate to State eligibility using September 1, 2017 as the cutoff date.
